Extract from the Constitution and Laws of the Grand Commandery  
 of Knights Templar of Pennsylvania - **Section Number 273**

**Section 273. (a)** Any Commandery, which shall fail to make its annual return or shall fail to make payment of the amounts so due by it before the fifth day of May in any year, shall be deprived of its representation in the Grand Commandery, exception as provided in Section 273 (b), and shall be notified thereof by the Grand Recorder under seal of the Grand Commandery; and if after three months notice it shall fail to make such return and payment, it shall be suspended until restored by vote of the Grand Commandery, or by order of the Grand Commander.
