**FURTHER**, EACH candidate must bring a copy of this Special Order, signed by the Petitioned Commandery Commander and Recorder and including the Commandery seal, to the Tri-State Order. All Pennsylvania candidates names will be read from individual signed and sealed copies of this Special Order prior to conferral.

**EACH** constituent Commandery will be responsible for confirming their candidate(s) had the Orders conferred upon them; and each constituent Commandery will be responsible for adding the new Sir Knight(s) into the York Rite Information System, (YRIS), before their September 2011 stated conclaves.

**ALL** preceding parts of this Special Order are to be read in full at the next stated conclave of each Commandery, and the entire Special Order entered in full or attached to the records.

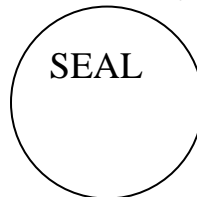

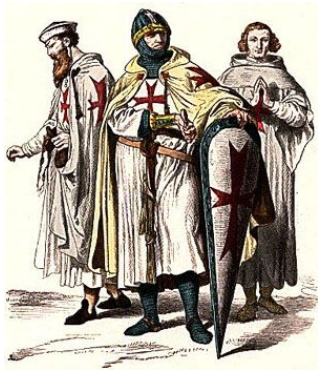
